#### 4. First-aid measures

#### 5. Fire-fighting measures

<b>Suitable extinguishing media</b>	Extinguish with alcohol-resistant foam, carbon dioxide or dry powder.
<b>Unsuitable extinguishing media</b>	Do not use a solid water stream as it may scatter and spread fire.
<b>Specific hazards arising from the chemical</b>	During fire, gases hazardous to health may be formed. Solvent vapors may form explosive mixtures with air.

#### 6. Accidental release measures

Stop the flow of material, if this is without risk. Prevent entry into waterways, sewers, basements or confined areas. Keep combustibles (wood, paper, oil, etc.) away from spilled material. This product is miscible in water.  Large Spills: Dike the spilled material, where this is possible. Following product recovery, flush area with water. Cover with plastic sheet to prevent spreading. Absorb spillage with non-combustible, absorbent material.  Small Spills: Clean surface thoroughly to remove residual contamination.  Never return spills in original containers for re-use.

## 7. Handling and storage

### Precautions for safe handling

The product is flammable, and heating may generate vapors which may form explosive vapor/air mixtures. Do not handle or store near an open flame, heat or other sources of ignition. Do not breathe the mist or vapor. Avoid contact with skin, eyes and clothing. Do not smoke. Take precautionary measures against static discharges. All equipment used when handling the product must be grounded. Use non-sparking tools and explosion-proof equipment. Use only in well-ventilated areas. Avoid prolonged exposure. Wash thoroughly after handling. Handle and open container with care.

### Conditions for safe storage, including any incompatibilities

Follow rules for flammable liquids. Keep away from heat, sparks and open flame. Store in cool place. Keep in a well-ventilated place. Keep container tightly closed. Keep in an area equipped with sprinklers. Keep this material away from food, drink and animal feed. Use care in handling/storage. Keep away from sources of ignition - No smoking.
