## SECTION 4: FIRST AID MEASURES

### 4.1. Description of First-aid Measures

**General:** Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible).

**Inhalation:** Remove to fresh air and keep at rest in a position comfortable for breathing. Immediately call a poison center or doctor/physician. Using proper respiratory protection, move the exposed person to fresh air at once. Encourage exposed person to cough, spit out, and blow nose to remove dust. ### 4.2. Most Important Symptoms and Effects Both Acute and Delayed

**General:** Causes severe skin burns and eye damage. May cause respiratory irritation. May cause cancer. Skin sensitization. Causes damage to organs through prolonged or repeated exposure.

**Inhalation:** Accelerated Silicosis can occur with exposure to high concentrations of respirable crystalline silica over a relatively short period; lung lesions can appear within five years of the initial exposure. The progression can be rapid. Accelerated silicosis is similar to chronic or ordinary silicosis, except that lung lesions appear earlier and the progression is more rapid.

Acute Silicosis can occur with exposures to very high concentrations of respirable crystalline silica over a very short time period, sometimes as short as a few months. The symptoms of acute silicosis include progressive shortness of breath, fever, cough and weight loss. Acute silicosis can be fatal.

**Skin Contact:** Concrete may cause dry skin, discomfort, irritation, severe burns, and dermatitis. Unhardened concrete is capable of causing dermatitis by irritation and allergy. Concrete dust, in association with sweat and friction, can lead to skin irritation and dermatitis. Skin affected by dermatitis may include symptoms such as, redness, itching, rash, scaling, and cracking. Allergic contact dermatitis is caused by sensitization to hexavalent chromium (chromate) present in concrete. The reaction can range from a mild rash to severe skin ulcers.

**Eye Contact:** Concrete may cause immediate or delayed irritation or inflammation. Eye contact with wet concrete can cause moderate eye irritation, chemical burns and blindness. Eye exposures require immediate first aid and medical attention to prevent significant damage to the eye.

**Ingestion:** May cause burns or irritation of the linings of the mouth, throat, and gastrointestinal tract.

**Chronic Symptoms:** Causes damage to organs through prolonged or repeated exposure. May cause cancer. Repeated exposure to respirable (airborne) crystalline silica dust will cause lung damage in the form of silicosis. Some studies show that exposure to respirable crystalline silica (without silicosis) or that the disease silicosis may be associated with the increased incidence of several autoimmune disorders such as scleroderma (thickening of the skin), systemic lupus erythematosus, rheumatoid arthritis and diseases affecting the kidneys. Silicosis increases the risk of tuberculosis. Some studies show an increased incidence of chronic kidney disease and end-stage renal disease in workers exposed to respirable crystalline silica.

### 4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

If exposed or concerned, get medical advice and attention. If medical advice is needed, have product container or label at hand.

## SECTION 5: FIRE-FIGHTING MEASURES

### 5.1. Extinguishing Media

**Suitable Extinguishing Media:** Use extinguishing media appropriate for surrounding fire.

**Unsuitable Extinguishing Media:** Do not use a heavy water stream. Use of heavy stream of water may spread fire. Reacts with water to form corrosive alkalis.

### 5.3. Advice for Firefighters

Do not mix with other materials. Vacuum clean-up is preferred. If sweeping is required use a dust suppressant. Contact competent authorities after a spill.
