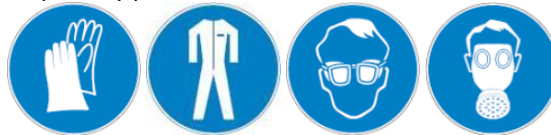
8.2. Exposure Controls
