SECTION 4: FIRST AID MEASURES

4.1. Description of First-aid Measures

General: Never give anything by mouth to an unconscious person. If you feel unwell, seek medical advice (show the label where possible).

Inhalation: Using proper respiratory protection, move the exposed person to fresh air at once. Encourage exposed person to cough, spit out, and blow nose to remove dust. 4.2. Most Important Symptoms and Effects Both Acute and Delayed

General: May cause respiratory irritation. May cause cancer (Inhalation). Causes damage to organs (lungs) through prolonged or repeated exposure (Inhalation). Skin sensitization. Causes severe skin burns and eye damage.

Inhalation: Irritation of the respiratory tract and the other mucous membranes. May be corrosive to the respiratory tract.

Skin Contact: When this product is wet it is corrosive. Concrete may cause dry skin, discomfort, irritation, severe burns, and dermatitis. Exposure of sufficient duration to wet concrete can cause serious, potentially irreversible damage to skin, eye, respiratory and digestive tracts due to chemical (caustic) burns, including third degree burns. A skin exposure may be hazardous even if there is no pain or discomfort. Unhardened concrete is capable of causing dermatitis by irritation and allergy. Skin affected by dermatitis may include symptoms such as, redness, itching, rash, scaling, and cracking. Irritant dermatitis is caused by the physical properties of concrete including alkalinity and abrasion. Allergic contact dermatitis is caused by sensitization to hexavalent chromium (chromate) present in concrete. The reaction can range from a mild rash to severe skin ulcers. Persons already sensitized may react to the first contact with wet concrete. Others may develop allergic dermatitis after years of repeated contact with wet concrete.

Eye Contact: Concrete may cause immediate or delayed irritation or inflammation. Eye contact with wet concrete can cause moderate eye irritation, chemical burns and blindness. Eye exposures require immediate first aid and medical attention to prevent significant damage to the eye. Causes permanent damage to the cornea, iris, or conjunctiva.

Ingestion: May cause burns or irritation of the linings of the mouth, throat, and gastrointestinal tract.

Chronic Symptoms: Long term exposure to respirable crystalline silica results in a significant risk of developing silicosis and other non-malignant respiratory disease, lung cancer, kidney effects, and immune system effects. May cause cancer (Inhalation). Causes damage to organs (lungs) through prolonged or repeated exposure (Inhalation).

4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

If exposed or concerned, get medical advice and attention. If medical advice is needed, have product container or label at hand.

SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

Suitable Extinguishing Media: Water spray, fog, carbon dioxide (CO₂), alcohol-resistant foam, or dry chemical.

Unsuitable Extinguishing Media: Do not use a heavy water stream. Use of heavy stream of water may spread fire.

5.2. Special Hazards Arising From the Substance or Mixture

Fire Hazard: Not considered flammable but may burn at high temperatures.

Explosion Hazard: Product is not explosive.

Reactivity: Calcium oxide reacts with water to form corrosive calcium hydroxide, with evolution of much heat. Temperatures as high as 800° C (1472 °F) have been reached with addition of water (moisture in air or soil). May react exothermically with water releasing heat. Adding an acid to a base or base to an acid may cause a violent reaction.

5.3. Advice for Firefighters

Precautionary Measures Fire: Exercise caution when fighting any chemical fire.

Firefighting Instructions: Use water spray or fog for cooling exposed containers.

Protection During Firefighting: Do not enter fire area without proper protective equipment, including respiratory protection. Hazardous Combustion Products: Carbon oxides (CO, CO₂). Crystalline silica exists in several forms, the most common of which is quartz. If crystalline silica (quartz) is heated to more than 870°C (1598 °F), it can change to a form of crystalline silica known as trydimite, and if crystalline silica (quartz) is heated to more than 1470°C (2678 °F), it can change to a form of crystalline silica known as cristobalite. The OSHA PEL for crystalline silica as trydimite and cristobalite is one-half of the OSHA PEL for crystalline silica (quartz).
