#### 4. First-aid measures

<b>Inhalation</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical attention if any discomfort continues.
<b>Skin contact</b>	Take off immediately all contaminated clothing. Chemical burns must be treated by a physician. Wash contaminated clothing before reuse. Get medical attention immediately.

#### 5. Fire-fighting measures

Clean surface thoroughly to remove residual contamination.
